WHEREAS, on March 19, 2001, the Mohave County Board of Supervisors voted 2 to 1 to support the Settlement Agreement proposed by county and court staff to resolve FY 2000 and FY 2001 budget issues; and

WHEREAS, \$157,932.35 has been transferred from amounts appropriated for the County General Fund Contingency Account for FY 2000 to various court departmental accounts for FY 2000; and

WHEREAS, \$104,510.00 has been transferred from amounts appropriated for the County General Fund Contingency Account for FY 2001 to Superior Court and Lake Havasu Justice Court departmental accounts for FY 2001; and

WHEREAS, \$104,510.00 has been authorized to be added to the FY 2002 baseline budgets to various court departmental accounts for FY 2002; and


WHEREAS, the Board of Supervisors has approved five positions as budgeted court FTE positions for FY 2001 and directed the County's Financial Services Office to assign appropriate budgeted position numbers to them; and

WHEREAS, the Board of Supervisors has acknowledged the existence of the Personnel Manager and Human Resources Technician positions as budgeted Superior Court FTE positions for FY 2001; and

WHEREAS, the parties have acknowledged that in the County's FY 2001 Budget, the Board removed certain mandated services from the Superior Court's lump sum budget and appropriated funds to cover their costs under separate, non-court budget, and the parties have agreed that funds appropriated to the Superior Court's Lump Sum budget for FY 2001 will not be used to fund the costs of the mandated services;

IT IS ORDERED that Administrative Order 2000-20 is hereby rescinded effective the date of this order.
